

## The Round Table on WP3

*An Italian Capitalization Event for the Best Practices in Health and Care, ICT and Mobility in the cross-border area.*

The 21st of January, the Polytechnic University of Marche (UNIVPM), organized and hosted an important Round Table under the capitalization work package (WP3) of AdriHealthMob project.

The objectives of this networking event were numerous:

- the overall presentation of AdriHealthMob Project
- the dissemination of results and goals
- the presentation of the developed data base concerning results and information collected through the analysis of best practices of initiatives connected to AdriHealthMob project
- the capitalization of other similar project or activities at local and National Level to collect and identify best practices from the Public and the Private
- the networking and the mainstreaming of policy and decision makers

The Round Table was opened by the Welcome Speech of Prof. Sauro Longhi, the Rector of the UNIVPM and also the scientific responsible of AdriHealthMob activities for UNIVPM and Prof. Francesco Maria Chelli (dean of Ancona School of Economics). The chair was the Prof. Marco Cucculelli.

During the event representatives of public and private bodies of local and national research centres presented and shared their own experiences in Health and Care, ICT and Mobility. It was an important occasion to capitalise the past and present experiences, getting the awareness of the potential of innovation that ICT can provide to health and care sector in the framework of mobility and accessibility; furthermore, it was the opportunity to confirm the coherency of innovative practices with the political schemes and operational programmes.

The event saw the participation of about fifty people among public representative, speakers, staff members, academic, students, researcher, etc.

### TECHNICAL MEETINGS

Technical Partners had a lot of opportunities to exchange opinions and to coordinate all aspects and issues connected to the developments of devices, platforms and ICT solutions, thanks to some technical meeting hosted in different situations and different locations.

After the SC and JTU meeting of Ancona (July 2014) they met themselves in several occasions: for example, on November 2014 in Sarajevo, to define strategies and Action Plan for operative task as WP4 (the mapping of health and care institution and of the cross-border mobility), on December 2014 in Bologna, to cover issues concerning piloting aspects of WP6 and in two times on January 2015 in Ferrara, to discuss aspects strictly connected with the development of ICT solutions and devices. All these meetings may be considered key moments for the progress and coordination of projects activities.
