

### Current situation regarding avaliable blood supplies in major emergencies

- Amount of blood reserves required to be available in cases of major emergencies at regional and/or national levels is not defined.
- Procedures for rapid mobilisation of blood donors in cases of major emergencies and procedures to ensure the quality and safety of such donations are not developed.
- There are no formal/informal arrangements with other countries to receive blood in cases of major emergencies.
