AdriHealthMob project

The AdriHealthMob project is realized within the Priority 3—Accessibility and Networks, Theme 2 of the IPA Adriatic Cross-Border Cooperation Programme and responds to the need to strengthen and integrate the infrastructure networks, promoting the accessibility of services.

Improvement of Mobility in Health & Care using ICT and Co-Shared Planning

On 25th of February 2015 Cross Fertilization Event, titled AdriHealthMob - Challenge, “**Improvement of Mobility in Health & Care using ICT and Co-Shared Planning in EUAIR**” was held in Durres, Albania. It was the occasion to deal with the topics of health and care, sustainable mobility and ICT with public and private Albanian representatives and AdriHealthMob partners, who presented and discussed their Local expertises, but also project first outputs and strengths. The event was attended by more than seventy participants.

AZUS as responsible beneficiary for work package 7 presented its activities on establishment of joint and sustainable transport in health and care. Entire work package is dedicated to planning and development of the most functional cross-border transport model for health and care, a process which starting point is establishment of the system for collection, systematization and analysis of data on patients, services and professional mobility. A major input for this process is comprehending relevant national framework, documents and policies of each of participating countries, that are involved in cross-border transport modelling.

Cross-border cooperation will allow improving transport routes for health and care, as well as to promote the development and networking of health and care resources in the Adriatic area.

ADRIATIC IPA Cross Border Cooperation Programme

The Cross Border Cooperation (CBC) is an instrument used by the European Union to strengthen cooperation between neighbouring geographic areas.

The IPA Adriatic CBC programme fits into the broader context of the process of pre-accession IPA (Instrument for Pre-Accession) and was founded on the basis of the previous INTERREG III, with the aim of strengthening cooperation and sustainable development of the Adriatic region.
